We expect you to provide details about this claim including: date, location, and other identification provided by "Holly Wilson."

Please let us know the court and case identifier for this action. We will happily contact the court clerk to contest it and provide to the court: my wife's birth certificate and SSN. Understand, I do not know you and identity theft is rampant. But if you will give us your attorney's name, phone number, and state whose bar under which he is registered, once we confirm through the state and business license his identify and office contact information, we will be happy to send him a certified, letter with my wife's birth certificate, a current photo, and SSN.

I will be following up to confirm reception of this FAX and the attached letter. But it would be much better if you send us a letter confirming the claim by "Advance America", "AGENCY CLIENT # 264517" against my wife has been stopped. Just be thankful my retired, paralegal, wife is not pursuing this matter as she takes too much joy in dealing with such issues. I'm the calm one.
